### Qualitative analysis of Criterion 1

Govt. Johnson College is an amalgamated institution of two private colleges; Bungkawn College and Khatla Arts and Commerce College amalgamated on 24 th October 2002. There are 24 permenant faculty members and 8 contract / casual teachers working. The College is co education institution and it is affiliated to Mizoram University. It offers UG programme in 6 disciplines of arts. The college is recognised under 2f and 12(B) status by UGC. It has adopted the Curriculum design and evaluation processes of the Mizoram University The University designs course curriculum for all affiliated colleges. Few faculty members are representing in BOS/Academic council of the university. The Academic Committee of the Institution prepares the Academic Calendar and implements the academic plan at the beginning of the academic year in accordance with the directives of the affiliating University. The time table committee prepares time table for academic year. Department time table is prepared in accordance with master time table. Lesson plan is prepared by the respective course teacher in line with university syllabus. The information about college, courses and curricular plan to the students is conveyed during an orientation program at the beginning of the academic session.

The Choice Based Credit System (CBCS) Course has been implemented from 2016 -17.

Cross cutting issues relevant to environment and sustainability and human values and ethics are included in the curriculum. The college is yet to offer yoga courses. Guidance is also provided to the students in the selection of various subjects offered by the Institution.

The college provides admission on first come first basis. Orientation programme is held every year for new students at the beginning of the Academic Session wherein students are introduced to the institutional system that may support their educational drives and personal goals; Remedial Classes, bridge courses and tutorial classes are conducted for slow learners. Group discussions and assignments are given to slow learners. Mentee-Mentor System is in place. For experimental learning, field visits and outreach activities like NCC, NSS, Adventure, Eco Club and Red Ribbon Club etc are arranged. The conventional lecture method of teaching has been adopted by all the teachers including video captured lectures through ERP of the college and through U- tube channels.

Evaluation of the performance of the students is done in accordance with the university norms. Internal assessment of 25 marks is done by the examination cell of the college and semester examination is conducted by the university. The college has grievance redressal cell to address the grievances related to examination. In case of university examinations the students are guided to approach university for redressal.

Well defined POs and COs for all programme are defined by the university and communicated to the colleges. The assessment of attainment of POs and COs by the college is not yet done.

The students of the college are honoured by the University for getting top ranks. The college has no placement cell, however they assist the students for their placement. ST students are offered scholarship as per government norms.

This is a under graduate college, the ecosystem for research and innovation is not observed. However, many of the faculty members of the college have published books, book chapters and research papers in journals. Out of 32 faculty members 7 faculty are holding Ph. D degree and 3 more are perusing the Ph. D. 4 faculty member are M.Phil and 10 are NET examination qualified. The college publishes research articles of faculty members in a book volume name as "Divergent Issues" with ISBN number.

The college has entrepreneurship knowledge cell in which various programmes like entrepreneurship awareness programmes, finishing school etc, are arranged. Skill development training programmes on banking was also arranged. The students of the college are encouraged to participate in training programmes organized by State Agriculture Management and Extension training Institute Aizwal.

The college publishes annual college magazine "SULHNU" in which teachers and students contribute articles. The NSS, NCC, Red Ribbon Club, Evanglical Union are active in the college. NSS conduct various extension activities in nearby villages. The college staff has donated funds and relief material during Covid pandemic. The student donate blood by organising blood donation camps frequently. Students are also involved in various other societal issues such as swatchh Bharat, voters awareness, sapling plantation etc. The students of the college also have "Self Support Union" to help provide part time jobs to needy students. Mizoram State Legal Services Authority established Legal Aid clinic in the college to provide legal services to people, students of the locality.

The college has received various awards Government Online Excellence Award for Govt of Mizoram, certificate of appreciation for their contribution in the youth symposium in 2021 by Asian Devlopment Bank.

The college campus is spread over 0.725Acre in the hill. The college has building blocks. Old building block consist of Library, administrative office and Principal office. New building block consists of 14 class rooms out of which 12 classrooms are provided with LCD projectors. One multipurpose hall, 1 seminar hall, departmental faculty rooms etc. are also there in new building block. One language laboratory having 20 computers with Sankov language software. Wifi facility with 100 mbps is available only in academic block.

There is no hostel for boys/ girls. No transportation facility to commute the students and staff from city to college. There is no hospital/ health centre in the campus. However one sick room with one bed is provided in new building.

The college has a room dedicated for indoor games like board games Table Tennis etc. there is no play ground available, however one basket ball court is available for practice. Students are encouraged and allowed to play outdoor games in outside play grounds.

The library has collection of 11376 books with 3497 titles. It has subscribe to 7 print journals and few magazine. They have not subscribe e- resources however they have access through Inflibnet. The library is partially automated by using SOUL 2.0 software and OPAC.

The college has installed CCTV cameras at strategic location. Water coolers are installed in every floor. Routine cleaning of the campus is done by in house staff.

The students are provided government scholarship as per govt. norms. About 60% of enrolled students are presently benefited with this. The college provide support for skill development of the student in various field like preservation and processing techniques of fruits and vegetables, importance of food packaging and labelling, fermentation of picking of fruits etc. the college conducted 3 months certificate programmes on Quantitative Aptitude and General studies to prepare students for competitive exams. The graduating students also supported to for to opt for their higher education.

The college has various cells namely Student Development and Welfare committee, Grievance Redressal Cell, Career and Counselling Cell, Anti ragging committee, Internal Complaints committee, Canteen Committee and Sports Committee etc.

The college has students union. Office bearers of the union are elected by the students. The student union member actively engagied in the activities sports, cultural and extension activities effectively.

The college has a alumni association having constitution in place however registration of the association yet to be done. Alumni meets are arranged every year. Alumni donated water coolers to the college and have also provided financial support of Rs. 8000/- from 2016-2019. They are involved in some of the student activities

The college is function under the Directorate of Higher and Technical Education department of Government of Mizoram. The college has well defined vision and mission. The college is a government college, affiliated to university. *The Principal as the head of the institution implements the decisions and policies of the institution along with the staff members.* The institution has decentralized its academic and administrative activities by constituting, the academic committee, the Examination Committee, the Admission Committee, the Library Committee, College Development, Sports Committee etc. involved in participatory management.

The college has no perspective/ strategic plan for the college. ERP is recently implemented in admission and academic areas.

The college has provisions of all welfare measures for teaching and nonteaching staff as per norms of

Government of Mizoram. The institution has adopted UGC's performance appraisal system and Academic Performance indicators (API)). Faculty members are permitted to participate in conferences, training programmes, workshops etc. However no financial assistance is provided to them. The non-teaching staff are promoted as per Civil Service Rules of Mizoram state.

The IQAC works on all quality evolving facets and conduct regular meetings. Feedback from all stake holders are collected and analysed by IQAC. The report is forwarded to Principal for taking necessary action.

The financial audit is done every year by chartered accountant and also by Accountant General of Govt of Mizoram.

The college has received RUSA Grant from 2017- 2019 amounting about 1.7crores for construction of class rooms, indoor hall, IT infrastructure and faculty appointment. In addition to this the fund is received from state government to meet salary and other miscellaneous expenses.

The college has successfully undergone Green Audit in 2021 awarded grade'A' approved by Mizoram Pollution Control Board

The college has arrangement to proper arrangement for dispospal of solid waste through local Muncipal Corporation .

As a green initiative the college has planted saplings. The college has yet take imitative of scientific identification of planted trees in the campus by using QR code tagged to provide information about the plants. Rain water collection is done and utilise in the campus.

The college celebrates National and International days In order to develop harmony towards culture, region, linguistic, communal, and social economic and other diversities. Mostly these programs are on special occasions and not a regular feature of college activities. Important National days like Constitutional day, Gandhi Jayanti, Ektha Divas (SardarVallabhBhai Patel), Martyrs' day, National Integration day, Independence Day, and a voters pledge programme. World environment Day, ethnic day are celebrated in the campus

Best practices mentioned by the college are routine in nature. These are student development programme and value based education on social responsibility .

Distinct feature of the college is to provide education opportunity to ST and girls student. The college student is also running 'Self Support Union' to help economically weak students by engaging them in part time jobs.
